ORDER:

In the G.O. 1st read above, Government accorded administrative sanction for establishment of Forest College & Research Institute (FCRI) within the premises of existing Mulugu Forest Research Institute in Narsampally RF, Medak District, duly allocating required budget of Rs.45.79 crores towards capital expenditure and Rs.6.00 crores towards recurring expenditure.

In the 2nd read above, the Principal Chief Conservator of Forests, Telangana State, Hyderabad submitted proposal for sanction of posts, both Teaching and Non-Teaching, for establishment of Forest College & Research Institute (FCRI) in Narsampally RF, Medak District to impart education in basic and applied Forestry to the students and also to provide research and employment opportunities on Forestry and related fields.

Government, after careful examination of the proposal, hereby accord sanction for creation of (118) posts, both Teaching and Non-Teaching over a period of five years from 2016-17 to 2020-21 as indicated below to run the B.Sc/M.Sc/Ph.D Courses in Forestry at Forest College & Research Institute (FCRI), Mulugu, Medak District commencing from the academic year 2016-17 for imparting the Forestry Education and Research.
